Minnesotans gather at Capitol to urge protection of human rights of all human beings

Event commemorates devastation of abortion on anniversary of Roe v. Wade

THOUSANDS OF MINNESOTANS converged on the state Capitol in St. Paul on Jan. 22 to give voice to the idea that human rights belong to all human beings and that both unborn children and their mothers deserve our support and compassion. **The annual MCCL March for Life marked the 46th anniversary of the U.S. Supreme Court's Roe v. Wade and Doe v. Bolton decisions,** which made abortion legal for any reason and stripped a whole class of innocent human beings, unborn children, of protection under the law.

"There have been more than 60 million unborn children killed by abortion, and more than 600,000 unborn babies in Minnesota alone," MCCL's Robyn Swiderski told the large crowd of citizens gathered from across the state. "Every single one of those children should have had a chance to live."

Legislative leaders address crowd

MCCL introduced its 2019 legislative agenda at the event during a brief program on the Capitol steps. The agenda calls on lawmakers to enact legislation ensuring women have the option to view their ultrasound prior to undergoing abortion.

"Women deserve to see the truth that an ultrasound shows," said Swiderski. **"They deserve to make an informed decision about a procedure that is life-altering not just to the child, but for the mother as well."**

Many of Minnesota's state legislators attended the March and were introduced during the program. Legislative leaders addressed the crowd and pledged their support for pro-life efforts.

"The right to life is a basic human right and should be protected by all those in elected office," House Minority Leader Kurt Daudt told the pro-life gathering. "Your presence here on a frigid January day is a testament to your belief in this cause."

Senate Majority Leader Paul Gazelka lauded the pro-life movement's incremental progress. "Being pro-life and protecting life from conception to death is something ... that we need to

MCCL CALLS ON LEGISLATURE TO ENSURE RIGHT TO SEE ULTRASOUND

Life-threatening measures considered this year will include ERA and assisted suicide

DURING THE 2019 LEGISLATIVE SESSION, MCCL will urge the Legislature and governor to enact a bill ensuring that abortion-seeking pregnant women can see ultrasounds of their unborn children.

Abortion facilities routinely perform ultrasounds before abortion in order to determine the development and location of the unborn child, **but women usually aren't offered the opportunity to view them.** The proposed bill would require that, when an ultrasound is performed prior to abortion, the woman be given the chance to see.

"Ultrasound provides women with factual medical information," says MCCL Legislative Director Andrea Rau. **"When people are better informed, they make better decisions that result in fewer regrets. Women deserve to see their child and know what abortion actually means."**

Rochester Planned Parenthood resumes webcam abortion practice

PLANNED PARENTHOOD has resumed prescribing chemical abortions through video at its Rochester facility, which does not offer surgical abortions.

In these "telemedicine" abortions, a pregnant woman at the Rochester center speaks remotely via webcam to an abortion practitioner located at Planned Parenthood's St. Paul headquarters. The woman then receives the abortion drugs (mifepristone, or RU486, and misoprostol) to ingest.

The webcam method allows Planned Parenthood to offer abortions in areas where it does not have a doctor. This expands Planned Parenthood's reach and increases its abortion total, **but it may exacerbate the risks to women of chemical abortions because no doctor is physically present when the drugs are dispensed or in the event of complications.**

Planned Parenthood introduced webcam abortions in Iowa in 2008 and then expanded them to the group's Rochester center in November 2010. The Rochester abortion practice ended in December 2015 before restarting in 2018. Planned Parenthood now says it offers webcam abortions in 13 states.

Minneapolis abortion center stops performing abortions

An independent abortion center in south Minneapolis has stopped performing abortions. **The clinic's abortionist retired from her private practice late last year.** She had taken over the business from her late mother, Mildred Hanson, who performed abortions for several decades. In 2017, the clinic was responsible for 565 abortions, according to the Minnesota Department of Health.

The retirement leaves Minnesota with just five abortion facilities (including Planned Parenthood's Rochester center). Planned Parenthood's St. Paul abortion center has increasingly dominated the abortion market, performing 6,234 abortions—more than 60 percent of the state total—in 2017.

Planned Parenthood releases new report on nationwide activities

The Planned Parenthood Federation of America released its latest (2017-2018) Annual Report in January. **It shows that Planned Parenthood performed 332,757 abortions nationwide in 2017, an increase of more than 10,000 over the previous year,** even as the group provided fewer non-abortion services like contraception and cancer screenings.

Planned Parenthood also took in a record \$1.665 billion in revenue—including \$563.8 million from the government—in the fiscal year ending June 30, 2018. **Planned Parenthood ended the fiscal year with \$244.8 million in "excess of revenue over expenses."**

In early January, responding to the idea that Planned Parenthood might pay more attention to non-abortion services in the future, the group's new president, Leana Wen, clarified what Planned Parenthood is all about. **"Our core mission is providing, protecting and expanding access to abortion and reproductive health care,"** she tweeted. **MCCL**

Research has found that abortion-seeking women who are uncertain of their decision are more likely to choose life for their child after witnessing an ultrasound.

An MCCL-backed ultrasound bill passed through both the Minnesota House and Senate in 2018, but it was vetoed by then-Gov. Mark Dayton. Despite significant opposition to the pro-life position in the House following last fall's elections, **MCCL is committed to working with elected officials again in 2019 to advance this important measure.**

ERA could undermine protection for unborn

The Legislature will also consider legislation relating to a proposed Equal Rights Amendment (ERA) to the Minnesota Constitution. **This effort is troubling because advocacy groups in other states have used ERAs to challenge and eliminate laws that protect unborn children or limit taxpayer funding of abortion.**

"Pro-lifers are strong supporters of equal rights. In fact, that is the reason we are pro-life—we believe that all humans should be afforded equal rights under the law," says Rau. **"However, ERAs have a history of discriminating against less developed humans, those yet to be born, and we do object to this."**

The problem could be alleviated if a clause is added to the ERA to ensure that it is interpreted as abortion-neutral.

Assisted suicide poses dangers

Another bill likely to be considered this year would legalize assisted suicide in Minnesota. **The measure would authorize doctors to prescribe lethal doses of medication so that patients can intentionally end their own lives.**

Among other dangers, the assisted suicide bill is not expected to include any safeguards after the lethal medication has been dispensed. Nor is the bill likely to require a psychiatric evaluation before the patient receives the drug.

"Assisted suicide is dangerous and unnecessary," says Rau. **"It would pose real risks to Minnesotans. All patients deserve support and care and protection, not suicide."**

A similar bill received a Senate committee hearing in 2016 but was pulled from consideration because it lacked the votes necessary to pass. **MCCL**

PRO-LIFE 101:

Pro-Life = Science + Human Rights

THE PRO-LIFE POSITION isn't just how we feel. It's not merely a belief that we hold. It is supported by very good reasons. It is based on a *fact of science* and a *principle of justice*.

A fact of science

First, the unborn (the human embryo or fetus) is a human being—a living human organism at the earliest developmental stages. This is a fact of science.

The empirical evidence of embryology shows that human embryos and fetuses are living (they grow, metabolize food into energy, and react to stimuli), human (they have human DNA and human parents), and whole organisms developing themselves through the different stages of life as members of our species. **Each of us was once one of them.**

A principle of justice

Second, all human beings—regardless of differences like age, size, ability, and dependency—have human rights. This is a principle of justice.

Unborn children may look different from other human beings, but appearance has nothing to do with value. Unborn children are less physically and mentally developed, but toddlers are less developed than teenagers, and that doesn't make them any less important. Unborn children are dependent on someone else, but so are newborn children and people with disabilities.

We have human rights simply because we are human—not because of what we look like, or what we can do, or what others think or feel about us, but rather because of what (the kind of being) we are. So every single human being counts.

Why abortion is unjust

The unborn is a human being, and all human beings have human rights. Therefore, the unborn human being has human rights, which include the right not to be intentionally killed.

That's why killing unborn children through abortion is unjust. That's why the pro-life position is actually true. **MCCL**
